

TOP FIVE REASONS TO BE SURE YOU PLAY IN THE NAP DISTRICT FINALS

- #5 You can have fun!
- #4 You can earn a Red or a Blue Ribbon Qualification by winning the district finals in your flight.
- #3 You can win red AND GOLD points at the district finals.
- #2 You can win double digit point awards by winning the district finals.*
- #1 You can earn a financial subsidy to attend the National Finals of the event.**

To be sure you know which flight is yours, think or look back to your May 6th computer cycle (the points that showed up on the back of your June ACBL Bulletin). If you were a Non-Life Master with fewer than 500 masterpoints at that time, you can play in Flight C. If you had fewer than 2500 masterpoints at that time, then you can play in Flight B. All others are in Flight A.

YOU MUST HAVE QUALIFIED AT A CLUB QUALIFYING GAME DURING JUNE, JULY OR AUGUST TO BE ELIGIBLE TO PLAY IN THE DISTRICT FINALS. THERE WILL BE NO EXCEPTIONS.

There is still, at press time, the chance that some of you will have the opportunity to play in the district finals at your local club, in an Electronic Devices Only section. Urge your club to participate, if you'd prefer playing there rather than driving to one of the two Finals sites (see ads, pp. 4-5). Check the District 9 web site (district9acbl.org) or watch promotional emails to know for sure.

One last note: you are expected to be a resident of District 9 on June 1st, in order to be eligible to play in the District 9 NAP Finals. If you have any questions about your eligibility, start by reading the Conditions of Contest posted at ACBL.org. Two full pages address how to determine if you are eligible to play in the district you wish. Then continue by verifying your eligibility by writing to D9 NAP Co-Chair Jeff Edelstein at jme317@aol.com or calling him at (347) 331-2200.

*Awards depend on several things, which are based on the number of pairs who enter the event. The winners of Flight C might win 10 or 12.50 or even 15 masterpoints (25% gold). The winners of Flight B might win 16 or 20 or 24 masterpoints, all gold. The winners of Flight A might win 24, 30 or 36 masterpoints, all gold.

**The Finals are scheduled for March of 2018 at the Philadelphia Spring NABCs.

Two District 9 Players Inducted Into ACBL Hall of Fame


At the Bridge Hall of Fame induction ceremony in July at the Toronto North American Bridge Championships, two of the three inductees are very well-known District 9 players. Jeff Meckstroth was the only player being inducted into the Hall of Fame this year based on his superstar status, while Zeke Jabbour was honored with the Blackwood Award, which recognizes long and outstanding contributions to bridge.

Zeke has been both loved by his partners and respected by his opponents. Others have thoroughly enjoyed reading his articles, for many decades. We hope you remember his Bridge Bulletin articles, but what you might not know is that he wrote a cover story for the Nov/Dec 2009 Sunshine Bridge News. Here's a truly great quote from that article, which Zeke entitled, Florida's Braggin' Rights. It talked about many of the famous and accomplished bridge players in Florida. When Zeke talks about Mike Becker, who comes from a famous bridgeplaying family, Zeke reported this exchange: Now add a little humor to the crucible...A few years ago, I was interviewing Mike about his famous bridge family. At one point I inquired, "Could I ask a dumb question?" "Better than anyone else, I'm sure," he shot back. Notice

how the master at humor (Zeke) stepped aside to let another superstar (Mike Becker) have the limelight. If you'd like to read the entire article, it's on page 26 of the Nov/Dec 2009 SBN. And if you'd like to read about Michael Becker, he was featured on the cover of our Nov/Dec 2007 SBN, on the occasion of his own induction into the Bridge Hall of Fame. That cover story is a particularly great one.

Zeke has been dealing with Parkinson's Disease for over 20 years, which has curtailed his bridge playing, and which caused him to depart from his Winsome and Loathsome column in the Bulletin. Over a decade ago, Zeke began to partner with the South Palm Beach County chapter of the National Parkinson Foundation in a special fundraising effort that has taken place now for ten years. Bridge players turn out as volunteers and attendees to a gala luncheon and bridge game. Fundraising efforts have contributed over \$700,000 during the ten-year history of the event. Over 50 professional bridge players volunteered to participate this past January, including Zeke and his wife Sharon.

In 2007, ACBL named Zeke the Honorary Member of the Year. This prompted us to Jabbour and his wife Sharon at the Hall of Fame banquet



choose Zeke as the subject of the cover story in the Jan/Feb 2007 SBN. Zeke, a Grand LM, won the Barry Crane 500 in 1989 and was Senior Player of the Year in 1995. He has won eight NABC Championships and earned a bronze and a silver in two world bridge competitions. Most importantly, Zeke has always been a charming partner and opponent with a great sense of humor.

Zeke was honored as the first recipient of the District 9 Sportsmanship Award, after which the award was named after Zeke. Zeke's wife Sharon tells us how pleased they both were to be able to travel to Toronto for Zeke to accept the award. "It was a whirlwind trip, and Zeke's only regret was that we returned home without his having played any bridge." We are delighted to congratulate Zeke on earning the distinct honor of the Blackwood Award.

As ACBL pointed out in announcing Jeff Meckstroth's entry into the Bridge Hall of Fame, his induction was a "first ballot slam dunk." When a player reaches the age of 60, he or she first becomes eligible for consideration. The honor is bestowed on players who have achieved prominence in the game of bridge and have an outstanding tournament record. Jeff fulfills those requirements! He has won nine World Championships and is fifth overall on the all-time World Grand Master list. In ACBL, he has won more masterpoints than anybody else, with his total over 84,500 at the time we write this article. Jeff graced the cover of the SBN for the May/June 2015 issue, although the cover story article only mentions him as winning his masterpoint category, ACBL-wide. Jeff has also been included in many composite cover photos, some when he was winning an NABC event, especially the GNTs, and some when he was winning most masterpoints for the vear.

Jeff and his partner, Eric Rodwell (you certainly may know them as Meckwell, for short) were on the winning team of the Championship Flight of the Grand National Teams five years in a row, ending in 2015. Since this is a competition amongst the 25 districts, these wins were wins for District 9. Jeff won seven other times for District 9 and once for a district other than ours. Add to all those GNT wins Jeff's other NABC wins, in all

Trick 1 Thinking

"Think at Trick One!" This is a theme I constantly try to drill into students. I am still drilling.

So many hands are lost at trick one due to failure to think. Usually, this is associated with declarer play, but defenders, too, must think at trick one. Here is an example from a deal I played long ago in a knockout teams. As West, you hold:

- **♠** A 72
- **♥** K 10
- ♦ K72
- **♦**86543

West	North	East	South 1♣
Pass	1♥	Pass	1♠
Pass	2 * *	Pass	2NT
Pass	3NT	All Pa	SS

* Fourth suit forcing

It sounds like they are prepared for all four suits. You try a \(\blacktriangleta \), selecting the 6. You don't want to lead low, because that will encourage partner to continue the suit. When he sees your highish spot, maybe he can read it as from a bunch of low cards, and switch if appropriate. Down comes the dummy:

- **♦** KQ10
- **♥**AJ97
- ♦ Q10982
- **•** 10
- **♠** A 7 2
- **♥** K 10
- ♦ K72
- **♦**86543

Declarer thinks about the hand for maybe 10 seconds, then tries dummy's ♣10.

Your partner plays the \clubsuit J and declarer thinks some more.

What are you thinking? Are you thinking? Are you daydreaming? Is this hand too difficult (they made all those bids, alerted, etc.)? Should I just wade through this deal and hope I don't have to do anything important and just wait for the next deal which might be simpler and more fun? What was the bidding again? Why are you bothering me with this?

Here are the many things to consider:

What is the club situation? Declarer was maybe hoping dummy's 10 would hold. Partner's jack is making him think. Declarer won't have ace-king-nine--he would take partner's jack without being too troubled. Partner would have played the king with king-jack (third-hand high), so the most likely scenario is that partner has queen-jack (if he had only the jack, declarer wouldn't be thinking). Also, partner rates to have the 9. (Again, declarer would not be thinking so long with ace-king-nine). So, it looks as if you might have hit partner with the QJ9 of clubs -- a good lead for a change.

Did your thinking end there? I hope not. Are you ready for trick two? What if declarer wins the club and plays a spade? In general, it is never good to play second-hand high. Grabbing your ace will almost always help declarer in these situations. Not only will it help his timing and entries, but he might be missing the ΔJ , and face a guess in this suit. You don't know enough about the full deal yet, so the best policy would be to duck and to do so smoothly! If you think about it at trick 2, you will be telling declarer where the ace is. So, you should be getting yourself ready for a spade play at trick 2 (smooth duck).

Is that all? No. What if declarer leads a low diamond from hand at trick 2? Again, you should follow general principles. Be prepared to duck, and to duck smoothly. Don't give away the location of the king.

Are you still thinking? Are you ready for a heart at trick two? This is a (rare) situation where

you should actually play second hand high! If declarer has the queen, he is always entitled to four heart tricks--your play won't matter. But, if your partner has the queen, and you play the 10, dummy's jack will go to partner's queen. This will simplify the suit and the entries for declarer. Meanwhile, if you hop with the king, he will have more difficulty. He might duck (playing you for king-queen). Even if he does win the ace, he will have to come back to his hand in some other suit to lead hearts again (he doesn't know your ten is falling). Lastly, if he happens to have \$\time\$Q83, he might win the ace and finesse into your \$\time\$10 on the next round of hearts.

Do you play Smith Echo? This is a wonderful defensive signalling method. When declarer starts his suit (for the first time), you don't give count. Instead, you tell partner if you are happy with the opening-lead suit. Playing high-low says "I like the opening lead." Playing low-high says "try some other suit--not the suit our partnership led at trick 1." This methods applies to either defender (opening leader or third hand). Almost all experts use this method. If you are playing Smith Echo, it is a good (ethical) idea to try to make your signal without lots of thought. So, in addition to all the above thinking, you should be ready to play the right Smith card. On a heart play, your king won't mean anything (honors are honors). BUT--if declarer plays a spade or a diamond, you plan to duck. Which spot you duck with will send a message. Are you happy with clubs? Do you want partner to continue? If so, you will follow (smoothly) with the ♠7 or ♦7. If not, you will play the deuce of that suit.

In fact, declarer does cross in spades. When dummy's king wins, he plays the ◆10 and lets it run. And you? Were you ready for a smooth duck of your ◆K?

I'll leave you here. The full deal is not important. I just wanted to illustrate how many things there are to think about. The time to do this thinking is at trick one. Part of good defense is not only knowing what to do, but being able to do it in tempo when the time comes. The way to become a good defender is to think through all of these matters at trick one. You must give every deal your full concentration. And, yes, I suppose some of you are wondering about slow play. You can't sit there forever at trick one--sometimes you can't prepare for everything.

Transfer Trouble



Jacoby and Texas transfer bids have become the system of choice for the great majority of tournament players. Besides making the stronger hand declarer, these bids provide a superior follow-up structure. The Texas transfer (unlike Jacoby by normal agreements) can also be used in competition, as illustrated by this deal from a recent team match

East-West Vulnerable,



Opening Lead: ♠K

All Pass

North's jump to 4 forced South to become declarer in 4. Normally, the Texas transfer shows at least six cards, but North took exception with his powerful five-carder—good judgment in my view.

So far, so good, but the trauma arose in the play. Declarer won the spade lead and drew two rounds of trumps, discovering the 4-1 break. Next came a club finesse, losing to the king. West cashed the ♠Q and continued spades, forcing dummy to ruff as East discarded his remaining clubs. Declarer was now history. If he drew trumps, he could never enjoy North's long club; and if he tried to unblock the clubs first, East would get a ruff. Too bad.

Careful play could have ensured success. Declarer should draw all of East's trumps (South discarding a spade) then play the ♣A and another club, taken by the king. West does best to continue leading spades, but declarer does not ruff the third spade, instead pitching a diamond from dummy. On the fourth spade, dummy ruffs, and declarer jettisons his blocking club on the same trick. The ♣10-9 are then clear to cash, and the ♦A takes the last trick

What Would You Lead?


The biggest money bridge tournament is the Cavendish Invitational, which takes place in Monte Carlo. It has an imp pairs event, and a teams. The hand below is from the final of the teams.

Your team is leading and you hear the bidding go:

West	North	East	South
	1NT	Pass	2♦ *
Pass	2♥	Pass	2* **
Pass	4♥	Dbl	Rdbl
All Pas	S		

You have three sure heart tricks. The King is likely in dummy with the redouble. What is your best chance of making a fourth heart trick? The answer is blocking declarer's communications, from drawing trumps at a late stage. Dummy has four spades and he may need these entries to draw your ♥6.

I think the right lead is to attack the entries with a spade. Here is the hand:



East led a club. Declarer won in hand, and played a heart. East split with 10, and declarer won and played a second heart. East won the Jack and tried a diamond. Declarer now played a third heart. East won the Queen. Declarer still had three entries in dummy and could force out the Ace of trumps and draw the 6 before claiming.

Try the effect of a spade lead. Now declarer wins in hand, and plays two hearts as before. You win the Jack and play a second spade. Declarer plays a third heart and you win the Queen. Now you play a club or diamond, it does not matter. You still have the Ace and 6 of hearts. Declarer has only a single entry to dummy, the •K. He uses it to play the •8 to your ace, but cannot get back to dummy, except by shortening his own trump length to draw your •6 which becomes the setting trick.

Your thoughtful lead envisaged this kind of end position.

This would obviously have been a huge swing. However, luckily for E/W, they survived this bad result and their team Zia held on to win the event.

Whenever a sectional (excluding STaCs) or higher rated event is being conducted within 25 miles of a club game's playing site, the club is permitted to hold only its regularly scheduled club masterpoint games (i.e., no special games).

Shirley Wright Interviews Cy Kick

Shirley: I have kibitzed you for three years now, and you have made an amazing transition from consistently scoring below average to nearly always coming in first or second. What are the secrets to your success?

Cy: Probably the most important change is the way I hold my cards. In the early days, week after week, players told me to hold my hands up. It would sink in for a board or two, but I would immediately return to my old habits. Believe it or not, the director told me it is perfectly ethical for a player to use the information I so gratuitously provided, as long as s/he does not go out of his or her way to peek. The cure is to sit as far back from the table as possible and to hold your cards vertically as opposed to slanted forward, which is a recipe for disaster. Take a selfie to check yourself out!

Shirley: I now see the opponents making a lot more errors against you than against most other players. What is your secret?

Cy: I try to wear my opponents' shoes and give them as many chances as possible to go wrong. Here are two examples.

Example 1: In a ♠ contract with ♥Q743 in dummy (never bid) and ♥82 in my hand, I need a ♥ trick. Since ♥ were not led, there is no way lefty has the ♥AK. The best chance is ♥AKx on my right. But wait, I lead a low ♥ at trick 2 from dummy. If righty has the ♥A and not the ♥K, am I trying to sneak through my singleton ♥K? If righty rises with the ♥A, I can later lead up to the ♥Q. I still will make a ♥ trick, if righty has ♥AKx, since the first ♥ would have been won by the ♥K.

Example 2: In a ♥ contract, I hold ♦J10 opposite ♦K7653 in dummy. I will make the hand if and only if I can hold my ♦ losers to one. At the second trick, before trump are drawn, I lead the ♦10 toward dummy. Lefty will nearly always go up with the ♦A if s/he has

it, fearing I am trying to score the ◆K opposite my singleton. If lefty plays low, I play low and hope lefty has the ◆Q. In the old days, I would try this later in the hand, when the opponents know a lot more.

Shirley: In a recent STAC game you were playing a 4 contract with \$Q7\$ in dummy and \$K8\$ in your hand. You won the first trick in dummy, crossed to your hand in trump, and led the \$8\$. When the \$Q\$ won in dummy, you claimed 12 tricks, as you could dispose of the other \$\ddot\$ on a \$\ddot\$. Why did you play the \$\ddot\$ in that direction as opposed to leading a \$\ddot\$ from dummy?

Cy: There are two reasons. First, doing it the way I did makes it appear I am going for a ruff in dummy, and the location of the *K is a mystery. If I lead low from dummy, there is no reason for righty to duck. Second, I considered the two opponents. It was a certainty to me that if righty had the *A, she would take it if I led a * from dummy. You cannot pull that sort of wool over this player's eyes. On the other hand, based on experience, the odds were good to pull this off against lefty. But had the players' seats been reversed, I would indeed have led the * from dummy. Some chance is better than none!

Shirley: I saw you pass righty's 1 ◆ opener, non-vulnerable, with ◆83 ▼AJ943 ◆1096 ★KQ10. Can you explain why you failed to overcall 1♥?

Cy: My left-hand opponent, Jack, is a much weaker player than my right-hand opponent, Mack. If I overcall 1♥ and the opponents are as expected 4-4 in ♠, Jack makes a negative double and Mack gets to play this. When I passed, Jack bid the expected 1♠, and went down in 3♠, whereas Mack would have made it. Another consideration is that for lead directing purposes, I had no preference

Play Hard, Play Well:

All of the Information

At a recent regional we had the following auction against a Precision pair.

Partner	RHO	You	LHO
Pass	1♠	2♥	Pass
2NT	3♠	4♥	All Pass

Dummy hits and we wish that we had given partner a chance to double $3 \spadesuit$. But now we must try to make $4 \heartsuit$:

- **★** KQ1054
- ♥ —
- ♦ J873
- ♣A762
- **.**—
- ♥QJ87632
- ♦ A O
- ♣ K 1083

LHO leads the ♠2. Plan your play!

It appears that we could lose 3 trump tricks and a ♣ and/or a ♦, so we have a lot of work to do.

When you are in a bad contract, it pays to be optimistic. The best situation is for one opponent to have AK doubleton of trump (RHO most likely).

We start by ruffing the first trick and then leading a low ♥. RHO wins the ♥K, just as we hoped.

- 1: ♠2 ♠K ♠A ♥2 (+1)
- 2: **♥**3 **♥**4 **♦**4 **♥**K (-1)

RHO returns a ♠ and we discard a ♣ on it as LHO ruffs. LHO then returns a ♣, which we win in hand.

- 3: ♠9 ♣3 ♥5 ♠4 (-2)
- 4: ♣4 2 Q K (+2)

Now we play another low ♥, which forces out the Ace. It appears RHO had AK and LHO 109xx, as we hoped.

5: **♥**6 **♥**9 **♦**3 **♥**A (-3)


We must not lose any more tricks, so when RHO returns another •, we ruff high and draw the last outstanding trump.

- 6: ♠8 ♥Q ♦5 ♠5 (+3)
- 7: **♥**J **♥**10 **♦**7 **♠**7 (+4)

At this point we have 2 trumps, 2♦, and 2♣ left in our hand and we must take all of the remaining tricks. We have 2 potential losers, a ♣ and/or a ♦, and we have the ♠Q on the dummy to use for a discard.

Let's take a minute and count. RHO had 5 points in ♠, 7 points in ♥, and at least 2 points in ♠ - for a total of 14 points. Remember that the opponents play a system where RHO's 1♠ opening bid is limited to about 15 points, so that means that the ◆K must be with West (where we didn't want it to be), and the ◆ finesse won't work. Instead of taking the ◆ finesse, we must play for the squeeze. We run all our trumps, playing LHO to have the long (3-card holding) ♠ and the ◆K. In this case, to protect their long ♠, LHO will have to discard down to stiff ◆K – and we will drop it offside!

After we cash the trump we get to this position:




BIDDING COMMENTARY: South opened 1♠ in third seat with a hand that was very "light" in high-card values. South's primary objective was to guide his partner's opening lead in the likely event that West became the declarer. The effect of South's bid was devastating for the opponents as it prompted his partner to make an otherwise unlikely opening lead of a small spade. If North had made his normal opening lead of the **V**Q, West would have easily fulfilled his 3 NT contract

PLAY **COMMENTARY:** South correctly plays the \$10 at trick one, compelling West to win his ♠K. Declarer then cashes his four club winners, ending in dummy to

finesse in diamonds. It's not a lucky hand for West as North wins his ♦K and plays a spade, allowing partner to cash his four remaining winners in that suit.

THE BOTTOM LINE: Opening "light" in third seat for lead direction can generate excellent results. However, such a bid is dangerous if a partnership does not have the protection that is provided by the Drury Convention.


BIDDING COMMENTARY: Having passed originally, South's 2♣ bid is Two-Way Reverse Drury, showing exactly three-card support for North's spade suit and limit raise values. North's 2 rebid shows full opening bid values coupled with four or more hearts. South's 3 rebid also shows four or more hearts and a willingness to play in that suit instead of spades.

North's 4♣ bid and South's 4♦ call are both control bids, showing first or second round control in those respective suits. North uses Key Card Blackwood to further investigate for slam. When South bids 5♠ to show two key cards (there are five key cards, the four aces and the king of trump, with the ♥K being a key card in this case), along with the queen of trump (♥Q in this case), North bids the slam in hearts. (Whew!)

PLAY COMMENTARY: This hand represents a classic situation in which a four-four fit produces more tricks than a five-three, or even a five-four fit. Whereas a spade contract would be limited to 11 tricks, 12 tricks are easily available in a heart contract. After pulling trump in three rounds, declarer discards two small clubs on his spade winners, then ruffs his remaining small club with dummy's remaining trump, thereby generating an additional trick.

THE BOTTOM LINE: In addition to facilitating the bidding of major-suit games, Drury can be very useful in the exploration of viable slam contracts.

BIDDING COMMENTARY: After East opens in fourth seat, West responds 2♣. Using Two-Way Reverse Drury, this bid shows gameinvitational values and precisely three-card support for his partner's major. East holds less than normal opening-bid values and shows his "light" hand by rebidding his suit at the two level, which his partner passes. NOTE: Without the use of the Drury Convention, West would have a challenging call after his partner's 1♠ opening. He does hold game-invitational values and adequate support for his partner's suit. Showing his assets with a jump to the three level may get the partnership too high when partner has opened on shaded values. However, bidding only 2♠ would understate his values and may result in the partnership missing game contracts on those occasions when partner has bid with full opening values.

PLAY COMMENTARY: defenders take the first three club tricks, South cashes the A and exits with another trump. Declarer has four winning trumps, the ♥A along with the ♦A and ♦K, for a total of seven winners. Declarer must look to the heart suit for the one additional trick needed to fulfill his contract. He pulls the opponent's remaining trump, then enters the dummy with the A to take a finesse in hearts. The finesse fails, with East's ♥10 losing to South's ♥Q. South then plays his remaining club, which declarer ruffs. He then returns to the dummy with the ◆K to play another heart. When North plays low, East finesses with his ♥J, winning the trick and securing his contract.

THE BOTTOM LINE: Drury provides your partnership with many benefits of opening with shaded values by allowing partner to show invitational values at a low level. Also, it frequently facilitates your partnership's ability to investigate both games and slams when you have opened a hand with average or above average values in third or fourth seat.

So People Can Bid Whatever They Please?

Recently I was called to a table where the opponents were aggrieved because North (third seat) had opened 3 with a five card suit. They asked his partner what he had, and they were accurately given the agreement that it could be six or seven. Another time, a player opened 2NT with only 18 HCP, but his partner, when asked, said it promised 20-21. Yet another time, it turned out that opener had only two clubs and had opened 1 even though she had three diamonds in her hand. This was not their agreement: their card said that either minor opening promised three or more. Her diamonds were the 753 and her clubs the AK.

Each time, the opponents properly gave their agreement, which happened to be at odds with the actual hand partner had. The Law is clear: as long as partner is as surprised as anyone else, you may vary from your agreement without reprisal (at least from the Director; I'm not saying that partner might not get after you). Another way to put this is that you're entitled to know their agreement, but not what's in his hand. It's the luck of the draw whether you'll benefit or suffer from the variation. I once had a partner decide to open 3♦ with his diamond void and seven clubs. He figured I'd lead a diamond on defense and he'd get a quick ruff. The only flaw in this logic was that I had five diamonds and was unwilling to defend! He ended up in 5♦ doubled for a nasty zero—and an unhappy partner.

Sure, he didn't have what he promised, but the opponents didn't call the Director because they were pleased with the outcome. It's rare that we get a call unless the variation has been a disadvantage to the opponents. In the case of the 14 opener on two cards: how can partner alert what he doesn't know? Making the judgment to bid a suit with two quick tricks instead of three small cards is hardly a major sin.

The problem arises when a variation has been used so often that it's no longer a surprise to partner. That is a concealed agreement and is both unethical and illegal. Change your card—and your explanations—to reflect your practice and there should be no problem.

But the answer to the question at the top of this page is Yes, on any given hand a player may vary from his partnership agreement. Even psychic bids are part of our game and are legal in ACBL play.

This is not to say that you can play any home-grown system or convention and just alert it because it's unfamiliar to your opponents. Take a look at ACBL's Alert Chart. If what you want to do is not covered there or on the General Convention Chart, you must submit your agreement to ACBL and have it approved. Even then, your local club has the right to permit or disallow conventions and systems in club games, though they must follow ACBL guidelines for Unit, District and National games played at the club (like STaCs and Instant Matchpoint games). Some conventions and systems are permissible only in extended team matches or high-level tournament events. They are defined on the Mid-Chart and the Super-Chart—both also available on the ACBL website

In addition to the General Convention Chart and the Alert Chart, take a look at the pamphlet on Alert Procedures. All three are available on the ACBL website under Helpful Documents. Not only are Alerts and Announcements thoroughly described, there are great examples of the situations in which they occur in Alert Procedures. It's not written in "legalese," and is easy to understand.

When in doubt, ask a Director. If your club has no stated policy on what is allowed or disallowed, it should adopt clear guidelines for the benefit and protection of the players.

MARINA KOTCH ATTAINS LIFE MASTER STATUS

The Journey to Life Master can take a lifetime for some; others accomplish the quest early in their bridge life. The Journey can be a story of tedious tournaments in hotels, clubs, and on ships. However, Marina Kotch's story takes a fifty-two year journey playing in stately European villas and chalets, bidding strictly in French, playing at tables where the players were addressed as Your Grace, Excellency, My Lords, and Madame.

When Marina's husband Mike's Battalion prepared for Viet Nam in 1965, Marina gathered the other Lieutenants' wives and suggested they learn to play bridge to fill the lonesome time of being left behind. The group acquired a book on the subject and began practicing at Marina's house, sitting around her coffee table.

All visitor/guests coming to the Pennsylvania's Tobyhanna's Army Depot found themselves questioned on their knowledge of bridge and if they played, they were guaranteed dinner and a game with Marina's group. In the next few years she joined the ACBL, read and played the game whenever and wherever she could. Her first bridge clan (Lieutenants' wives) had scattered across the world on assignment, but the ladies continued to play competitive bridge.

By 1968 Mike was assigned to NATO's Supreme Headquarters in Belgium and would spend several years assigned to various NATO posts in Europe. Marina began playing bridge during the day, but the best games were in the evening. This international play was a "partner draw", no usual

partners in these games.

Men dominated the bridge scene, which was fraught with men and women of rank and privilege making the entrance to the bridge activities hard for anyone, much less a young military wife. Hard because she was serving in diplomatic posts with its own mandatory etiquette, language, and protocol – her actions reflected on her country and her husband. She worked on her defense skills, new bidding protocol with its French language requirement, and the differences between American and European bridge rules.

Marina received no master points for the duplicate play abroad, but began adding to her original points upon her return to the states in 1983, primarily playing in the greater DC area. She received her last qualifying point for Life

Master in May 2017 at the Fort Myers McGregor Point Bridge Club with her regular partner Nancy Baer.

We asked Marina to tell us who her favorite partner was and she said without hesitation, "Major General Spadaccini, Italian Air Force" who was very tolerant of her beginner play rank. Her favorite bridge game was at the Knights of Columbus in Arlington, Virginia where three-time world champion Steve Robinson doubled her bid of 4 Spades, she redoubled and made the bid! She still looks forward to reading Robinson's weekly email broadcast.

Marina encourages new duplicate players and hosts a regular open Tuesday night game. She underscores that she does not teach, but invites new players to the table to play the game and discuss the hands. She is available for bidding questions during the play. Marina is not a believer in using a lot of conventions during bidding, but rather bid along and play defensively. She repeats what she learned from Steve Robinson, "make every card count". This Italian born woman is tough and determined, but is also a gentle, kind, and forgiving mentor to those who want to learn.

between ♣ and ▼, the likely unbid suits. Of course if Jack had 5♠, he plays the hand regardless. Taking account of the relative skills of the opponents at your table is vital to play at bridge clubs, where, over time, you play a significant number of boards against the same players.

Shirley: Lessons from this interview: (1) When someone tells you to keep your cards up, listen. It is the most important bridge tip you can receive. Many players will just enjoy the view, and not tell you. (2) Be creative in thinking about giving your opponents problems. Give them as many opportunities to err as possible. A mistake by them is as important as great defense or declarer play. (3) "Different strokes for different folks". In clubs, we get to know our opponents very well. This helps you tailor your game to your opponents.



We cross to the ♣A and cash the ♠Q, discarding our last ♣. This leaves us with a ♣ threat in the dummy and a ♦ threat in our hand – squeezing LHO.

Remember when the opponents tell you a lot about their HCP from the bidding, counting points can be very helpful in placing the honors late in the hand!

Note that RHO could have beaten us by shifting to a ◆ or ♣, instead of returning a second ♠, but I'm sure they hoped to beat the contract by promoting a spot card in the trump suit for their partner.

This indicator is from the collection of Dawn Ligon who is Larry's Marketing Director and an addicted collector of Trump Indicators. From the forward of the book: "The cover photo is of an original 1920's Trump Indicator or Bridge Marker which is from Dawn's private collection. It was made in Germany and is painted metal with paper tabs to help remind the players of trump. Notice the No Trump (American) vs. No Trumps (European). Whist and Bridge Markers were frequently used up until the 1950's and are highly collectible."

Joan tells us that her absolute favorite in this category, which is now in the American Contract Bridge League museum, is a crosscollection piece of a Disney character, Felix the Cat. Disney collectors are often reluctant to share their Disney Memorabilia with Trump Indicator collectors even if it is a trump indicator. They are very protective of their Disney turf.



In 2008, Joan Schepps donated her private collection of Bridge Markers (over 600 pieces), including the Felix the Cat, to the ACBL Museum for permanent display at ACBL headquarters at Horn Lake, MS.



"Nancy and Jim Heston co-chaired the raffle committee. They spent many hours collecting items donated by residents and gift cards donated by area merchants. Nancy designed the themed baskets and displays. The Hestons' talents raised \$4,000 in raffled items.

"The delicious lunch for the Longest Day attendees was purchased from Metropolitan Ministries, an area non-profit which feeds the homeless. SCCDBA was happy to support both causes.

"Volunteers sold tickets, welcomed the ticket holders, set up and directed the bridge games, worked in the kitchen, prepared and cleaned the venue, and were available to guide attendees to the proper areas. Cheryl Macphee donated the use of a condo during the Orlando regional to be raffled off.

The Sun City Center Community has supported the Longest Day for three years and its residents and area bridge players look forward every June 21st to a day of bridge, fun, community connections and good works. Information about SCCDBA can be found on its website scebridge.com."

Frank Hacker sent a report from the Lee County Bridge Association. Frank tells us, "Our club has two games a week, Wednesday at noon and Friday at noon at the Annunciation Greek Orthodox Church in Fort Myers. Our attendance is pretty strong. We had over 2,400 tables last year and have had over 1,100 tables for the first five months of this year. This should be well up in the standings for a club with just two sessions a week.

"We are a membership club and charge \$5 to play. The Longest Day fell on Wednesday, one of our normal days to play, so we thought we would give it a shot. We voted to send all proceeds to Alzheimer's research, retaining nothing for expenses. Our treasury is fairly strong and we could stand the loss of revenue and the extra expense.

"We scheduled three sessions of bridge at 18 boards a session. The sessions started at 9:30, 1, and 3:45, with a buffet lunch at noon. We made it a day long party with refreshments throughout the day. We also gave away a number of free entries as door prizes. Our members provided a lot of the food, but we supplemented it with wraps and other items from Costco. We had lots of leftovers, so we had a bit of a party on Friday as well.

"Organizing something like this takes a lot of effort. Our board outdid themselves as did many civilian members. I regret that we didn't take any pictures, but I would like to give a tip of the hat to Steve Pilzer, Charlene Collins, Rita Artwohl, Rich Green, Marilyn Barker, Al Kimbrough, Jo Sheraw, Sharon Pierce, Gilda Reynolds, Robin Spriggle and our director Richard Blandford.

"Our revenues came from a number of sources. First were the card fees. We also had many additional donations from participants and from people unable to actually come on the day of the game. We had a small bake sale and a silent auction of gift certificates to local spas, restaurants, etc. The bidding was very strong on these items and many went for substantially more than face value. Bev Nelson and I (the local pros) donated sessions of bridge. These were very popular as well.

"The results were stunning and exhilarating. We had 50 tables in total for the three sessions of bridge. The revenue there was \$1,000. We had over \$1,900 in additional donations, over \$800 from the silent auction and a bit more from the bake sale.

"The grand total was \$3,913. This was a cooperative effort by the entire membership. Everybody was charged up by the results which greatly exceeded everybody's expectations. I had hoped for \$1,000. We'll all be on an emotional high for quite a while."

Another smaller club with great results was Gainesville. Thanks to Jon Shuster for the report.

"The Gainesville Bridge Club, with just 70 dues paying members, raised over \$4,000 for three Longest Day sessions to benefit the Alzheimer's Association. Ron Schoenau and Mary Ann McIntyre did amazing jobs organizing the event, and a good time was had by all. The Night Session had an innovation in the Pro-Am concept, that other clubs may want to try in the future.

"We recruited Pros who were not only very seasoned tournament players, but were

delightful to play with. Instead of auctioning off individual Pros. we asked for blind pledges, and highest seven each drew a Pro out of the hat, in order of the size of the pledge. "Ams" had a great night taking three of the top four finishes Beth Paul and Pro Josh Feldstein came in first overall, earning 2.77 masterpoints each, by far the biggest haul to date for Paul"

By the time read this vou we'll article. have been able to read how the ACBL-wide effort did. and with these three iust 128 Unit clubs

contributing \$21,000, it's a good guess that a truly significant amount will be in the hands of the Alzheimer's Association. We expect them to use those funds wisely and perhaps we'll actually hear of a breakthrough towards treatment or prevention, in our lifetimes.

My father was a ham radio enthusiast. He served in World War II as a radio technician in Pearl Harbor. When I was growing up he had his ham radio set in the basement of our home and I remember him spending hours on the radio with people from all over the world. He died in 1988 at the age of 66.

Here I am at age 62 and I spend several hours a week on BBO playing bridge against people from all over the world. Turkey, Iran, China, Canada. Countries near and far. Bridge cuts across all political and cultural spectrums.

I always love to hear how people came to play bridge. Many players had parents who played social bridge and cut their teeth as children against adults. It's the best memory of my parents in my life and it lasted for several years.

In 1981 I moved to Raleigh, NC and started playing duplicate and tournament bridge. I remember early on psyching a one spade bid with a void. My partner promptly raised me to four with five spades which was quickly doubled and down for a zillion. At least I kept them out of their 4-4 spade fit. I also played against much younger versions of Jerry Helms, Kay and Randy Joyce and Nick Nickell. Unfortunately when I returned to my parents' game in New Jersey things were different. I remember a crucial deal when I cue bid my opponents' suit. A literal explosion followed the conclusion of the bidding with accusations of bidding a suit I did not hold. The end of our cherished family game soon followed. The memories of the earlier games are gold.

As your new president of Unit 240 I look forward to serving you and meeting you!

THREE UNUSUAL HANDS


During my 25 years of playing bridge, I have held three very unusual hands. TWICE, while playing with my partner Lyn Giuffrida at the Vero Beach Bridge Center, we held 13 spades between us. Once was unbelievable. A few months later it happened again. Some professional players, who play a lot more than I do, have told me they have never had a hand like that.

But, the hand I want to write about today, took my breath away. It's been several years since I encountered it in a pairs game at a Gatlinburg Regional. East was the dealer, N/S were vulnerable and I was sitting West. My partner passed and South quickly bid 3 spades as I was trying to believe what I was holding.

So, I thought....I see two losers in my hand, South has a fairly weak hand, North must want to bid, I need to shut her out, and finally, my partner, hopefully, has ONE trick for me. I took a deep breath and bid 6. North passed.

My partner, having no hearts, but thankfully, having faith in me, passed. When my partner's hand came down, and I saw the \bullet K, and knew I had it made. North could not lead a spade because she didn't have any! Surprisingly, only three other pairs in our section bid \bullet V. And, one managed to make 7 by putting the squeeze on North who foolishly discarded the \bullet Q to keep her \bullet K, forgetting that the declarer had trumped her \bullet A on the opening lead.

President's Message

It particularly saddens me this is Muriel Altus' swan-song as editor of the Sunshine Bridge News (SBN). Muriel has been editor longer than the 13 years I've lived here. The first time I read the SBN, I was bowled over by the quality of Florida's little newsmagazine, and it became the only bridge publication I carry with me on a daily basis. I particularly depend on the SBN's pin-up, that is, the tournament calendar comprising the middle of each issue.

Here are my two Public Service Announcements: 1) The schedule and hotel reservation numbers for our Dec. 2017 Regional can be found on the flyer in the Tournaments section of the ACBL website, or page 9 of this issue. 2) Please see Keith Gellman no later than Sep. 8th if you wish to run for the Unit 243 board from 2018 through 2020.

Here are the answers to my second and third questions from 2016 Helen Shanbrom Ace of Clubs winners in the 0-5, 2500-3500, and over 10,000 points categories. Question #2: What is your best tip for your favorite partner? and their answers are as follows:

David Kupperman (0-5): Whether declarer or defender, taking a moment to think about the bidding sequence to determine possible lines of play. Always return your partner's leads and watch for signals. Remember that your partner may also have a source of defensive tricks and think about possible ways to reach your partner to cash those winners.

Sanford Robbins (2500-3500): As I "mature", I notice that I am making more mistakes and errors. I find that [receiving] negative comments in front of opponents breaks my concentration and leads to additional errors on the next board or two.

Bella Ionis-Sorren (10,000+): Not to dwell on mistakes. There are plenty more boards and one can overcome bad ones if you concentrate on the new hands. Also to lighten up and enjoy the session.

Question #3: What would you have the clubs and tournaments do differently to improve duplicate bridge?

David: I think the clubs need to do more to recruit new players to the game to keep the game growing, such as coordinating a youth program with local schools. Encourage I/N players to attend events and tournaments by having limited games designed to attract them. At tournaments, it would be great if there were signs on elevated stands that identify where sections are, especially in a Swiss team event where it's always difficult to find the next table.

Sanford: I would suggest that there be stricter enforcement of the zero tolerance policies since I have seen many pleasant, enjoyable afternoons and evenings ruined by misbehavior.

Bella: I think that clubs have to be more conscious of zero tolerance and help players behave better. Clubs should have more mentor sessions to bring newer players into the game and make them comfortable. Also, they should enforce some actions against slow players that deliberately slow things down by sitting and discussing the hands when it is over. It makes the game unpleasant, especially for the east-wests who have to follow them. Also, north-south should be aware that they have to pass the boards in a timely fashion, and not make the next table wait. Also, I do not think that the bridge mates should show all the results. People tend to read them aloud and it gives other players a heads up on the board. The clubs might also add a small question and answer period after each game with volunteer "A" players to help the beginners.
